I WENT DOWN TO HAVE SOME JUICE IN KITCHEN I NOTICED IT WAS JUST AFTER MIDNIGHT HE CAME DOWNSTAIRS & SAID, (1) OUR CHILDREN ARE SCREAMED UP (2) YOU (ME) ARE A DEFECTIVE HUMAN BEING (3) YOU (ME) ARE FULL OF FEAR THEN HE WENT BACK UPSTAIRS. I WENT TO BED

I SPOKE TO MY LAWYER ON JUNE 7 & SHE TOLD ME TO LEAVE PREMISES WITH CHILDREN IF IT HAPPENED AGAIN. SHE ALSO SAID SHE WAS CONCERNED FOR ME. SHE SAID THIS (IS ABOVE) TYPE OF INCIDENT IS USUALLY THE BEGINNING OF DAMAGING ABUSE. I ALSO SPOKE WITH MY DR. - DOCTOR SELBYN SMITH & HE ADVISED THAT I COULD FILE REPORT WITH POLICE

OFFICIAL DATE OF SEPARATION - APRIL 9 / 94. HUSBAND STILL LIVING IN MARITAL HOME WITH WIFE AND TWO CHILDREN. WIFE SLEEPING IN ROOM WITH CHILDREN.

ON EVENING OF JUNE 6, AFTER I HAD GONE TO SLEEP HUSBAND BILL ROSS CAME INTO BEDROOM, SAT DOWN ON MY BED, (CHILDREN WERE SLEEPING IN BED ABOVE) GRABBED MY WRISTS TIGHTLY AND SAID - "I KNOW WHAT YOU ARE & I KNOW WHY YOU ARE THE WAY YOU ARE. YOU HAVE HURT ME BADLY AND I HAVE DONE NOTHING TO YOU. I WANT TO KNOW WHY." I STRUGGLED TRYING TO GET MY WRISTS FREE & HE TIGHTENED HIS GRIP MORE. HE WENT ON TO SAY "I MIGHT RAPE YOU HERE" - HE REPEATED THIS TWO OR THREE TIMES. I SHOWED NO FEAR. I TRIED TO FREE MY WRISTS. I TOLD HIM TO GO TO BED. HE KEPT REPEATING "I WANT TO KNOW WHY" (ie I HAD MET HIM LASSER) I ASKED HIM IF HE HAD BEEN DRINKING - HE SAID NO. HE REPEATED THE RAPE THREAT. HE WANT TO KNOW WHY. HE WOULDN'T LET ME GO. HE COMMENTED AGAIN ON MY DESTRUCTION IN COURT. I TOLD HIM HE WAS GOING TO TRY & DESTROY ME IN COURT. I TOLD HIM HE DISGUSTED ME. I TOLD HIM TO LEAVE ROOM. THE CHILDREN SLEPT THROUGH THIS. IT LASTED ABOUT
