DETAILS OF OCCURRENCE AND ACTION TAKEN:

AT 0753 I RECEIVED A CALL IN CENTRAL FROM CATHERINE ROSS. SHE EXPLAINED THAT SHE WAS AT HOME AND WAS JUST INVOLVED IN A HEATED ARGUMENT WITH HER HUSBAND BILL ROSS, WHO LEFT THEIR HOUSE VERY ANGRY. DURING THEIR ARGUMENT HE HAD APPARENTLY THREATENED TO "CAMP" OUT AT MITEL IN ORDER TO GET HER SIGNATURE ON SOME DIVORCE/SEPARATION DOCUMENTS. SHE REQUESTED THAT SECURITY PERSONNEL AT ALL ENTRANCES BE NOTIFIED OF THE SITUATION AND OF BILL ROSS' DESCRIPTION. CATHERINE ALSO ASKED TO BE ESCORTED FROM HER VEHICLE (MAZDA 626) INTO MITEL PHIV AT APPROXIMATELY 0843. SHE ARRIVED AT PHIV AT
