

June 25

Computer Room equipment removed. Bad argument between Bill and I because he tried to make me promise Khierstyn that I would not break his PC - she plays Inspector Gadget on it. He was using the children again. She was beside herself but I would not allow him to use the children to get his way. I told her I would get her a computer and I knew he would remove the equipment anyway. I told him to back off the children. He went out. I was very angry. I called the OPP in West Carleton to report removal of equipment and just to let them know what was happening with Bill's moving out on June 27th. I also reminded the OPP of his threats of rape outlined in the report I filed on April 8.

June 26

OPP dropped by to talk with Bill - friendly visit. I saw them by accident and went out and introduced myself. He took the children to my Dad's that afternoon. When he left, he threatened to be back in a few days. He told me he would be late returning the children on Monday night. I reminded him that the Agreement stipulated 9:00 p.m. and he told me I was not the boss.


June 27

Bill moved out. I called him twice to ask how late he would have the children back - he did not return my call. He was back at 9:15 p.m. and told the children prior to this that I would probably have the cops out after him. I told the children the above. He left at 9:45 p.m. with threats that he would be back in 4 days if I did not agree with provisions he wanted (what these were I forget) and that it should be leaving not him. I asked him for a telephone number that he could be reached at in case of an emergency and he told me it was none of my business. He also did not let the dog out at 5:00 p.m. that evening when he was at the house - I called our neighbour and asked Peggy to do it.

June 28

I called Dianna Drynman to get his number and address in case of an emergency. Dianna told me that she had been told by both Bill and her ex-husband not to tell me. Khierstyn told me eventually - he was living with Dianna's ex-husband and the kids had the

- phone number. Telephone broke at home. Apparently Bill called and called. He got Dianna to call our neighbours to see if I was hanging up on him. I told her the phone was broken. I called Di to let Bill know. this.
- June 29 Bill told me he was taking girls all day Friday July 1 (holiday) and he wanted me off the premises. This was not in Agreement which said he picked them up after daycare. (I had to get Katrina involved in this.) He started to talk shortage of money - I reminded him that we only discuss the children as outlined in the Agreement. I informed him that I had copies of the girls' report cards for him and hung up phone.
- June 30 I had girls. I told Bill that he could have the girls early on Friday July 1 - i.e. 3:30 pick-up and that two child support cheques per month were fine instead of one lump sum payment of \$700. It would make it easier for him. He did not call girls that night i.e. Thursday June 30.
- July 1 I took kids to movie. He picked them up at 3:30 p.m.. I told him where I could be reached if he needed me. He called me at 6:30 p.m. and asked me to come home early because he was too sick to look after children - he had a cold. I told him he could see them on Sunday p.m. if he wished since he had lost time with them that night.
- July 2 He called girls in p.m.
- July 3 He did not see them in p.m. like I offered. Instead he called kids and complained to Khierstyn about his lack of money. He also came to pick up rent from next-door and poked around property. He took his bike. He knew we were away - we went out to a petting zoo.
- July 4 I had girls.
- July 5 He was in. He did not do anything with girls in evening. He did not even water the puppies. House left in a mess. Spoke to me re. tranquilizers and said that he was going to stop being petty.
- July 6 I had girls. He called and wanted to talk with a third person present because he did not want to deal with lawyers.
- July 7 Bill with girls. He requested I come home at 8:00 instead of nine and then later left a message on my voice mail asking me to make it 7:00 instead. I did not get this message until later. Got home - girls not even bathed and the house was a mess. I left him a schedule of the cleaning up after pups and the animal care I'd look after over his weekend with the kids. He would not do any of it - not feeding, watering etc.
- July 8 He called again requesting third party discussion and avoiding lawyers. I refused. He called my sister Laura and asked her to try and talk some sense into me. She blasted him and hung up on him.
- July 9 Many items returned to house such as stereo system, my cook books etc. which were removed on an earlier date. Katrina you have an itemized account of these.

- July 10 House left in reasonable shape. He kept pressing me to talk with third person and not use lawyers. I sold pup at Mom's.
- July 11 Bill had Khierstyn clean up all the dog dirt on kitchen floor. He told her it was one of her jobs. I asked him if he would like to spend July 29 with the girls (his evening) since our caregiver was away. He said why did I not do it. I said because I do not get paid and I thought he would like the time with them. He refused so I got a sitter in.
- July 12 I was informed that he intended to proceed with assessment.
- July 13 He had girls. House left in mess.
- July 14 I had girls.
- July 15 I got home at 9:00 and girls not bathed yet.
- July 16 I was home and started showing and selling pups.
- July 17 Girls and I went to Brockville with sister and family for swimming and picnic.
- July 18 I had children. They got hair cuts and I cleaned the house.
- July 19 He took children to movie and did not get them home until 9:40 p.m. I did not know where they were and had to call our caregiver to find out. I asked him to take children out later in week if he was going to be late and to let me know in advance or at least leave a note.
- July 20 He called re. vacation. He can not take children on vacation because I have left him no money. Reminded him to go through his lawyer. He refused.
- July 21 More talk from him about things other than children. I left stuff out for Bill and kids for supper and locked the freezer because he was taking a lot of food out of house. He took the Cuisinart and large Tupperware bowl. I got home at 9:00 and children not bathed and house a mess.
- July 22 I am home.
- July 23 Khierstyn called me at Mom's and told me that Bill had broken into the freezer.
- July 24 He was in car ready to go when I got home - more items were missing. Khierstyn called and said he was making her blow up their water float swimming boats because he did not have the air pump I had. He wanted the air pump. Khierstyn called again to tell me that neighbourhood child had been lighting fire bombs, cigarettes and matches in the tree house. I asked her where her father was while this was going on and she said he was reading the newspaper. Peggy our neighbour looked after situation. Later I banished the child from the property. Khierstyn said that Bill also refused to fix the broken chain on the swing set. He said that Rick next door could do it. I fixed it, but with great difficulty because Bill took all the tools. When I got home at 9:00 the children were running around in evening air with bathing suits on - i.e. not bathed. House was a mess.
- July 25 Bill's night and he forgot. Caregiver called me at 5:10 p.m. and I called him. Kelly said they were going out at 5:30. The agreed time for pick up is 4:45 p.m. at daycare. I got home and it was a

chilly night. Children were bathed but in underwear - I told them to go put warm p.j.'s on. He laid down some rules re. tree house and told me he expected one half the money for pups. Khierstyn went after him and told him no he was not going to get any money for pups because Mommy had done all the work. He further told me that he had spoken to Rick our neighbour re. treehouse. I checked this out with neighbours on July 26 - Bill had said nothing to them.

- July 26 I am home.
- July 27 Nothing done - house a mess and animals not fed. Chilly and girls in underwear. I noticed China sold to Mom gone and a lot from freezer. I packed up car with chairs, pictures, my books, my CD's (anything of mine and sentimental value) under Katrina's direction that night. and removed them the following day. I also got serial numbers of everything which he had returned and anything else which could be taken.
- July 28 I had girls.
- July 29 He took microwave oven, all the stereo equipment (again) and miscellaneous items with the girls watching on.
- July 30 Girls and I bought new pictures and tried to make place as much a home as possible. He called that night and girls told him about pictures and asked him not to take them because they were theirs.
- July 31 He did not call girls.
- Aug. 1 Girls and I visited friends. I put lock on tenant's storage compartment to store vacuum, sewing machine, etc. to prevent removal. I also found out I had pleurisy and pneumonia at doctor's.
- Aug. 2 He had girls. Khierstyn had tough time with Bill and told him she would go and stay next-door at Peggy's.
- Aug. 3 I signed papers to get custody assessment started.
- Aug. 4 Bill late picking girls up at daycare - i.e. 5:10 p.m. I had to leave work early because of illness.
- Aug. 5 Girls with me. No call from Bill.
- Aug. 6 Bill was 15 minutes late picking girls up from swimming lessons.
- Aug. 7 Bill finally got into storage room of tenants to see what was in there. Told Peggy he needed the vacuum cleaner which he could see through window to clean car - he did not clean the car however.
- Aug. 8 Bill did not pick kids up until 5:00 at daycare.
- Aug. 9 I had girls.
- Aug. 10 I got home at 9:00 to find girls being punished for throwing water into fan in their bedroom. They had been playing in their room which is next-door to the computer room where Bill was reading a book. He told me to follow through on his punishment etc. The thing is, is that the children do not act this way normally and if he was right next-door then why didn't he notice what was going on. Anyway they went to bed early without a story or a hug and kiss. They did not get a story from me but we did have a discussion and they got their hugs and kisses anyway.

- Aug. 11-
Aug. 19
Aug. 20
Girls with me on holiday at Red Pine Camp.
Got girls home for Bill's weekend; then went and bought groceries and deposited them at home. He followed me around the house as I noticed that he had taken the waterbed, bookshelves etc. during our holidays. Then he accused me of stealing his mail which I did not do.
- Aug. 21
He asked me to be home at 7:00 because he had a dinner engagement. (Interesting that he wants to leave early on his weekend after he has not seen his kids for a week.) The house was also a mess.
- Aug. 22
He had girls - would not look at me...very subdued.
- Aug. 23
I had girls. Khierstyn told me that she was mad at me because I was not home all the time and she said he father treats them like slaves. He did not call girls that night.
- Aug. 24
Bill in. He did not play with them or read them a story.
- Aug. 25
Girls with me. Khierstyn said she is happier when I am home than when Daddy is there.
- Aug. 26
Bill with girls. Same thing - kids tired, house a mess, animals not fed.....
- Aug. 27-28
He did not call girls all weekend and they did not ask to call him.
- Aug. 29
No call from Bill for girls again.
- Aug. 30
Bill has girls. Did not get home until 9:15. No note left to any notice given. He was angry about something. Took more clothes and did not leave house until 9:30.
- Aug. 31
Girls with me. He called at 7:00. Katrina sent letter went to Vivien granting him long weekend because it was fair - I felt he should have it since I had other long weekends.
- Sept. 1
Bill with girls. Letter came wanting change in Agreement as to child support and visitation hours. I refused. He said that my weekend could start tonight. He wanted to talk money etc. I told my lawyer would be in touch with him and reminded him that we were only to discuss the children. He collected the rent and was out like a shot when I got home. He did not leave a child support cheque which was due September 2.
- Sept. 2
Bill called wanting to discuss out-patient therapy for Khierstyn - he wanted to start this. I asked him if he had spoken to Dr. DeCorte re. this and he was evasive - i.e. "It is none of your business" he said. I called him and left a message on his voice mail reminding him that the child support cheque was due today. The cheque never arrived.
- Sept. 3
Bill was supposed to be at the house to commence his weekend with them at 10:45 a.m. - he was 40 minutes late and refused to give me any more money. He said I had bled him dry.
- Sept. 4
He called and asked me to hold off on legal action and said he would try and borrow the money from someone. I decided to wait until his next day with the girls to see what he did. I called Katrina and told her the situation and asked her to hold off on action later in the week.

- Sept. 5 Bill with girls. When I got home at 9:00 p.m. the children were not in bed; had had no story and they were both sick with colds due to lack of sleep during their weekend with Bill - i.e. 12:10 a.m. on Saturday night and late on Sunday p.m. The house was a mess; the dishes were not done and the animals were not fed.
PLEASE NOTE HERE KATRINA THAT IT IS LIKE THIS WITH THE CHILDREN, THE HOUSE AND THE PETS EVERY NIGHT AND WEEKEND THAT HE IS IN THE HOUSE - I STATE THIS WITHOUT ANY EXAGGERATION - AND HAS BEEN SO EVER SINCE HE LEFT AT THE END OF JUNE. IT IS ALL LEFT FOR ME TO DO! EVEN ON SCHOOL NIGHTS THE CHILDREN ARE UP WHEN I GET HOME. As he left that night he called me a bitch.
- Sept. 6 Bill did not call children.
- Sept. 7 Bill with kids. Same situation as usual when I got home. No child support cheque left. Laura Harris (my sister) retracted the statement she had given Bill with Katrina.
- Sept. 8 Me with girls. Action initiated with Katrina re. cut off of child support. Loan arranged on my life insurance policy to pay for girls' dance classes, winter clothing etc.
- Sept. 9 Bill with girls. He forgot Khierstyn's medication for a spider bite at caregiver's house and did not go and get it. The girls and I went to Kelly's at 9:15p.m. and picked it up because it was an antibiotic that she had to have at regular intervals.
- Sept. 10 Girls and I went to visit my sister and family in Maitland for weekend. I informed him of this in case he needed to get in touch with us.
- Sept. 11 Bill did not call girls. Khierstyn also said that she wished she did not have a father.
- Sept. 12 Girls and I got them registered in dance class.
- Sept. 13 Bill in with girls. I got kids registered in their swimming lessons in evening. That day I called him and told him that a doctor's name he was looking for for Dr. McLean at the Family Court Clinic was on one of the calendar's he had removed. He played dumb. I told him that Dr. McLean had told me that Bill was also looking for the name and not to give me any garbage. He called me twice about it and denied having the calendar's and told me to look in my own stash. I looked again at home - nothing there. I later informed Dr. McLean that it was useless trying to find the name. Bill also called my sister Laura that day and told her he wanted to stay on good terms. She hung up on him.
- Sept. 14 I had girls.
- Sept. 15 Bill with girls. On his way out he yelled at them to clean their room. I went up stairs and it was a disaster. Khierstyn was angry at me for not being home. (Katrina, please note that this is a very common thing with Khierstyn - she is always angry when I am not at home. Also of importance is that the children never destroy their room when I am with them.) Khierstyn said that it had not been a good evening. The children also had not had their story and

- Khierstyn was not allowed to have her dessert because "she had missed her chance".
- Sept. 16 Girls with me. We got the kids winter boots and dance slippers purchased that p.m. and had dinner out.
- Sept. 17 Bill's weekend with kids due at house at 10:45 a.m. He called at 10:30 and told me to meet him in Ottawa at 11:30 a.m. at McDonald's to drop the kids.
- Sept. 18 When I got home at 9:00 p.m. what I found enraged me. Children extremely tired. They had had spaghetti 2 nights in a row. They had not had any fruit or vegetables all weekend - most of the cookies and all of the tarts, and candy however were gone. They did not have supper on Saturday night until 8:30 and did not have breakfast until 11:00 a.m. on Sunday morning and they had been up very late on Saturday night. The house was a total right off - dirty laundry piled high and a whole weekends' worth of dishes sitting on the counter. The bottom line is that the children had not been properly taken care of and he did nothing around the house - he left it all for me to do Sunday night. The children were very glad to see me - I wonder why?! They were also very angry.
- Sept. 19 I called Dr. McLean to see when he would be seeing the children - I wanted things moving because the children are not taken proper care of when Bill is with them. I called Dr. DeCorte for advice on dealing with the girls' anger. Bill was with children that night and once again took off like a shot when I got home. The children were still up and the house was the same - a mess.
- Sept. 20 I started teaching. Dianna Drynnan looked after children. When I got home Khierstyn was angry that I had not been home and wanted Di to go home. Dianna is good with the girls - this indicates that they want me with them all the time.
- Sept. 21 Bill with girls. Khierstyn angry with me in a.m. because I was not going to be home that night. I left him a breakdown of the phone bill - he discovered he owed \$94 in long distance charges. He threatened to hit me on his way out.
- Sept. 22 Girls with me. Bill called and relayed message through Khierstyn that he would not be picking them up on his weekend until 4:00 p.m. I got on the phone and he gave me the same information. I told him not to relay message through children and reminded him of the agreed upon time. Like always however, he received no emotional reaction from me.
- Sept. 23 Bill is with kids. Same situation at home when I arrive.
- Sept. 24 I'm with kids. We went to the Carp Fair.
- Sept. 25 I sent fax to Bill re. changing his appointment with Dr. McLean which also involved the children. Hilary up crying in night with sore knee made me change my mind about cancelling her chiropractic appointment which was scheduled at the same time as the appointment Bill set up with Dr. Mclean. He called. He was very angry. He said I had no right to do this. He said he did not agree with chiropractic and that he had a letter from the family G.P. saying it was not necessary. I reminded him of how the

chiropractor had straightened Hilary's leg last year when she was so badly crippled up that she was limping and her leg was turning inward. I reminded him of how Dr. Johnston (the chiropractor) had straightened Khierstyn's leg out when she was learning to walk - she was toeing in badly - and how she walked fine now. I reminded him of the numerous appointments he had with Dr. Johnston after we had a car accident 3 years ago. I said you only object to it because I set it up. He said "I object to everything you do". (that sums it up - he objects to everything I do regardless of the good which may result from my decisions). He objects because I do them and because of the money he may have to put out towards chiropractic treatments in the future. He also called Dianna and cried to her and she called me and balled me out. Her anger was soon gone.

- Sept. 26 He called Dianna re. above again. He called me at 7:20 p.m. to see if I had changed my mind re. the appointment saying he could not get an appointment until Oct. 3. I said no I had not changed my mind and that it was not a big deal because I was not seeing McLean with the girls until September 30. I called the township re. property taxes due on September 22 - they still were not paid. He was late paying the last ones too. Bill did not call girls that night.
- Sept. 27 Bill called at 7:45 a.m. to see if I was going to change the appointment which was that morning at 8:30. I said no. He was with girls that night and children and place were the same when I got home from teaching. I was able to change my class times to allow me to get home by 9:00 p.m. rather than 10:00 which I used to do.
- Sept. 28 I am with kids.
- Sept. 29 Bill with kids. Took them out for supper and bought them bubble bath. Children not in bed when I got home. House in same shape. I left him a note reminding him of the time he agreed to of 10:45 and asked that if he wished to change his arrival time on Saturday would he please leave me notification in writing. He did not.
- Sept. 30 Children with me.
- Oct. 1 Bill did not arrive at house for his weekend until 4:00 p.m.
- Oct. 2 Bill put Khierstyn in charge of Hilary at 1:30 p.m., went to bed and told Khierstyn that she was to waken him at 4:00. He further would not allow the children to call me to take care of them. They did however call their grandmother looking for me and Khierstyn told her that Daddy was sleeping and that he had told her to look after Hilary. I found this out when I checked in with my Mom to find out if the children had been looking for me - this is something I always do and Mom always knows where I can be reached in case the kids have a problem. Bill is aware of this as well. When I arrived home that night, I found the children extremely tired and getting sick. Khierstyn said they had not been properly taken

care of this weekend. They were angry and generally upset. The house was a disaster.

Oct. 3 Bill in with kids. He forgot to take them to their dance classes. Same situation when I got home as usual.

Oct. 4 I taught class and had a good sitter in with girls.

Oct. 5 I left a memo for Bill on the table outlining how his behaviour with the children on his last two weekends had not been up to scratch and suggested that he make a concerted effort to improve his care of the children when they are with him. I also told him that if he would not let the children call their mother to care for them when their father was unable, that he call someone else in.

DIARY OCTOBER 8TH TO NOVEMBER 18TH, 1994

October 8, 1994 Bill showed up in a.m., nosing around house.

November 3, 1994 Bill wrote "great reckoning" on calendar, attached.

November 4, 1994 Visitor to house at 2:30 a.m., opened screen door, closed it, and left.

November 14, 1994 Discovered computer cable strewn into attic, with hole through ceiling.

November 16, 1994 He said "you can bring the booze in now".

November 17, 1994 He called at 6:00 and said he wanted to talk, I said "No".

November 18, 1994 Bill had kids. Called to have kids picked up at Mom's, asked Bill to call back confirm -- on phone -- he wanted me to come home earlier. When arrived, he asked her to come back 10 minutes early to talk -- she said "No". At 7:00 p.m., he called me at Mom's, said wouldn't talk to him. When she got home at 9:00, wanted to know where children would be on Friday & asked whether they should bother going to Court on Friday -- I said I wouldn't discuss with him. For several minutes, tried to get him to leave, repeatedly saying "Good night, Bill" -- he just kept following me around.
