Dear Madam:

Re: Ross Matrimonial Matter

Thank you for your letter of June 29, 1994. When we discussed the matter of issuing the Order arrived at on consent on June 23rd, on that date, my client was not concerned as to whether or not the Order was immediately issued. However, I have no recollection of any agreement to issue the Order. The parties had agreed to an arrangement which would exist on an interim interim basis, without prejudice. She anticipated that the parties would live by their agreement. Since that time, she has had reason to develop concerns. She advised me that your client has told her that he will not pay her anything, despite the existence of the consent reached requiring payment of \$700.00 per month in the interim. Therefore, she has instructed me to issue the Order, so that she may enforce the support requirement therein in the event that your client does not meet his obligations under the consent.

While my client is amiable to arranging the support payments so that they are made in a fashion other than once monthly, no specific proposal has been put forward by your client.

With respect to the assessment, I am surprised by the contents of your letter. I advised you at Court on the 23rd that I had no objections to him acting as an assessor, and I still do not. However, I specifically indicated to you that I have had other assessments conducted by Dr. Stevens in the past, which took a considerable length of time. I therefore advised you that I would also be contacting other assessors with a view to finding out how quickly an assessment could be done by other psychologists. I have contacted Dr. Acher. She advises that she would be prepared to commence the assessment immediately, and would be prepared to provide a report to us by the end of August or beginning of September. I have also spoken to Dr. Peter Judge, who advises that he would be prepared to commence the assessment immediately. He will, however, be away for the month of August. Accordingly, he has advised me that he would be prepared to attempt to complete the assessment by the end of July, but if it were not completed by the end of July, it would be completed in or about the end of September. He has advised me that he wants to review his schedule to determine the likelihood of completing the assessment by the end of July. I am awaiting a return call. I have also left a message with Dr. Harrison's office and am awaiting a reply.


