This is to inform you that we have received your objection. The review will be done by the Appeals Division of the Canada Revenue Agency, which has a mandate to conduct a full and impartial review of the decision taken by CRA officers.

An Appeals officer will contact you or your authorized representative to review all the facts and discuss your objection. The Appeals officer will also ensure that the basis of the (re)assessment is understood, and will offer to provide you with the documents relating to the issue(s) in dispute. Based on our current inventory of cases, we will contact you or your representative within the next six months.

If you have not paid the amount in dispute, interest continues to accumulate on the unpaid balance. You can reduce or avoid interest charges by making a payment on your account. The Canada Revenue Agency will pay interest on any amount it refunds to you if your objection is allowed. The Revenue Collections Division has been advised that you have filed an objection.

In order to expedite the resolution of your objection, it would be helpful if you would have available any additional information you wish to provide.

Your correspondence includes a request for relief that can only be granted through the exercise of Ministerial discretion. This request will be considered under the Taxpayer Relief provisions of the Income Tax Act, however, it may be considered after all appeal periods have expired.
