**Regarding: The ongoing predatory war against myself, family, Canadians and western civilization in general**

## **Executive Summary:**

War (algorithm) defined: demonize, socially / economically isolate, move in for the kill, feed from the carcass, next prey.

The repetitively proven facts of this ongoing matter is a particular instance of a general, escalating threat than has vexed and caused great harm to mankind and peaceful civilization, for all of recorded history: The eternal war between predator and prey.

Historically, proven methods of crime fighting, cui bono (who benefits) and follow the money have been used by honest law to differentiate between predator and prey, because the basic, historical function of law in western civilization has been predator control, to secure social peace and freedoms so that productive people can engage in honest division of labor (civilization). Prey are those whose lives and property are harmed and stolen for the benefit of predators. The flow of resources is easily measured and leads away from prey and towards predators. If law is corrupt, or fails, crime pays and predators collect power at the expense of the prey and civilized. If this trend continues, eventually (as in now),

predators claim absolute power for themselves which corrupts absolutely. This arbitrary power is used to further prey on the productive, collapsing peaceful division of labor which is civilization. The current social / economic statistics of escalating violence between arbitrary political viewpoints, economic collapse and war of western civilization is a symptom of the root cause that the rule of law has fallen to predators and potentially productive people such as me cannot be so without attracting predators.

The above consequences to predatory behavior are due to a very basic and inarguable fact of life: If people and their families are attacked, they must defend and time and energy (their lives) must be diverted to defensive conflict, making peaceful division of labor impossible. This eventually results in no economic resources (productivity) available to pay the salaries of honest government and law and social / economic collapse. This historically proven fact of life is totally independent of the pretexts / excuses predators may use to rationalize destroying civilized people. It is not rocket science to comprehend that when the civilized are prevented from being so and destroyed, so is civilization, a product of the civilized.

I continue my efforts (and will until I am killed, the historical fate of all who dispute being slaves or dead) to convince the insane that that their subversions, subjective opinions, illegal actions and aggressions attempting to control / enslave peaceful, free people and the productive are contrary to fact, objective law and proven reality with the cumulative, ongoing effect of social / economic collapse for Canada, part of an identical trend collapsing western civilization, as similar predatory actions against the productive collapsed socialism and the USSR. The basic reason for the west is that, in seeking political support, "consent of the governed" has devolved to "consent of the appeased" at the expense of "consent of the productive". Those who actually work, innovate and produce wealth are the only segment of society that is capable of providing the support that government and law, as non-producing entities require, which is why you are public servants, tasked with keeping the peace that any civilization and productive economy requires. This matter is a basic conflict between fact, law and reason versus rule of opinionated man, an alliance of corrupt elements controlling government and law claiming that they are master and, the rest of us, or at least the productive are serfs.

Not a single human being considering the facts of this matter would be able to tolerate these aggressions against themselves and family and, most would have been destroyed independent of whether they complied or dissented. I expect to continue to be oppressed for the simple reason that you, if a public employee are a pawn in a tyrannical hierarchy, at risk by dissent of the party line. The choices of our public servants in this matter (contrary to peace, civilization and law) has remained "better me than you". What you fail to comprehend is that these crimes, if unopposed will also result in YOUR demise, as they have for all of known history. The facts and evidence of this matter prove a treasonous smash and grab predatory assault on Canada and Canadians from which all of us are and will be collateral damage.

Historically, when governments are limited by objective law, applied equally to all human beings (rule of law), peace, innovation, jobs, prosperity are available to all who are willing to participate in peaceful division of labor. Historically, when governments claim to be master, forcefully destroying dissenters, unbound by anything except opinionated "rule of some men, enslaving others", the people become

slaves and the resources required for peace, innovation, survival and prosperity must, for basic survival reasons be diverted to defense. Predatory pillaging of my life, family and lawful affairs by the divorce courts acting against the stated goals and parental responsibility enumerated by clear law (Divorce Act, which I support and have complied with) is what destroyed my ability to continue my engineering career and be able to continue to contribute to the significant jobs and prosperity I once provided for Canada and Canadians. Cumulative assaults on the productive and work ethic have placed Canada on a path to social / economic collapse, as common interest has been replaced by a war among predatory and unproductive special interests, seeking special legal status (entitlements) at the expense of others. Corrupt rule of man, on the bench and fall of rule of law is the root cause, by imposing inequality under law for (insert fake excuse of the day here) and government and law have totally lost credibility.

If you are in government, I have been defending my family against the law being abused as a predatory instrument, contrary to written law, as created by our duly elected representatives. I have been, to the best of my ability fighting for objective law, in the common interest of all Canadians. Our elected representatives are well aware of the predatory carnage to children and families as a consequence of enforced inequality under law in the divorce courts, to the point that a joint committee of Parliamentarians and Senators researched the matter of the legal profession's illegal conflict creating methods such as false allegations, hearsay, inequality under law, rationalizing clear law away, ignoring proven facts which impoverish and destroy families with a bias towards the irresponsible parent, to the profit of the legal "profession". Their final conclusions ([Report on the Special Committee of Child Custody and Access](#)) was released in 1998, recommending an end to this illegally created conflict and immoral assault on families. The conclusion can only be that the legal "profession" is running a protection racket, to the detriment of the family institution and children learning how to be civilized (peaceful division of labor, work ethic). [Department of Justice responded](#) and refused to deal with this. DOJ's basic excuse was, OK, looks bad, we'll change terminology (excuses, but, not behavior). The conclusion can only be that obeying the law is bad for the legal profession, who interpret the law contrary to the stated will of lawmakers and claim their subjective interpretations and opinions to be the standard of truth. My opposition in this matter is not a general rejection of government and law, it is a rejection of criminal elements within and forcing government and law to return to their jobs as accountable public servants bound by rule of law, as opposed to master.

The majority of politicians, judges and public servants are just following orders / process, participating in the social / economic demise of Canada, oblivious to the part they play, a harmful and therefore treasonous act against Canadians. Our highest laws clearly state: we are ALL personally responsible for the consequences of our own actions and, following orders / process is not an excuse. The ultimate result is you are accessories to crime. I know that internal dissent carries the survival threat of losing your job, perks and pensions. There is no effective whistleblower protection. So does the social / economic collapse which is an inevitable consequence of proceeding on present course, with further consequence of facing the wrath of Canadians. You are pawns in this matter, to be discarded when no longer of use. You should also note that threats for your dissent are similar (loss of job / survival threats) to how everyone, public servants included were terrorized and controlled in Nazi Germany, under penalty of immediate execution by the SS. It should also be apparent that you are not serving Canadians, but minority criminal factions within the apparatus of state.

I have already, repetitively explained / proven the facts and criminal illegality of this matter, only to be repetitively met with ongoing strategic denial of the facts and law, escalating threats and obstruction of justice. Prior to myself and family being bushwhacked, assaulted, impoverished and abused by corrupt

lawyers and judges in the matter of my divorce, I was a highly productive engineer, creating many manufacturing jobs and prosperity for my fellow Canadians and paying taxes, by my innovation. The programs I once conceived and led added hundreds of millions of dollars to the Canadian economy and paid much tax. I was entrapped in a decree of man situation, contrary to clearly written law where I could not continue my career or be prosperous without harming my daughters due to being forced to subsidize my (legally proven) totally addicted, irresponsible, negligent ex-wife, by the forceful eviction of the only personally responsible role model (me), from my daughters lives, creating an intellectual vacuum to Pavlov condition / adapt my daughters to dependency and welfare state, entitlement mentality. This was NOT in my daughters best interests, so, I, at great personal sacrifice / cost, in opposition to what were clearly illegal judicial decrees, without breaking any laws, peacefully remedied the situation to avoid this inevitable outcome and avoided being an accessory to crime by tolerating corrupt judges to prevent me from achieving my moral and legal responsibilities to care for and teach my daughters to be morally aware human beings, with the skills, values and intellects required to be self-sufficient in a peaceful division of labor civilization. I am at high risk from arbitrary force (rule of some men, enslaving others) for acting according to fact and obeying the law, as written, accepting and achieving my personal responsibility to my daughters to prepare them for life as it is, as opposed to how social manipulators would like to force it to be, to make a predatory profit, contrary to all objectively interpreted written law, for common good (minimal harm). By teaching my daughters to not be dependents, to be personally responsible, I saved their future husbands from much woe and Canadians from two more mouths and my daughter's children for the welfare state to feed, as a pretext of arbitrary power to "help the unfortunate". I broke / avoided the welfare (dependency, whining and voting for appeasement) trap for my daughters and their progeny. I have provably acted in the interests of my fellow Canadians and honest government and law in this matter.

Not much more than a century ago, I or any free human being could have clicked my ruby slippers together and said the magic words: "I DO NOT CONSENT" and be immediately whooshed back to life among the peaceful and civilized. I or anyone could have approached any honest judge, stated and proven the simple facts that I and my family are being bullied, enslaved, impoverished and do not consent and had an instant resolution and compensation for harm done, at the expense of the perpetrators. I have to the best of my ability peacefully opposed the illegal demands that have and are being forced upon me, refused to be provoked to violent defense, unsupported by any equally applied law. Now, far too many tolerate (terrified to oppose) that the legal "profession" can rationalize, manipulate, lie and delay such matters indefinitely using overwhelming taxpayer resources, while it is decided whose basic right to peace, life and security of person and property is superior to who's, contrary to the legal, rule of law truth of "equal treatment in terms of measurable rights and responsibilities".

Society has become a conflict between officially decreed predators and decreed prey. These reasonable, historically proven laws are still on the books, but it has become unfashionable to enforce them and the people have been lobotomized by politically subverted education, forgotten our collective history, meaning of freedom and ability to critically think. I could not become an engineer until I suffered from, discovered and rejected the nanny state lies of my public education making me irresponsible, a very painful process during adolescence, which I helped my daughters to avoid.

Most believe people have become stupid and lazy and that common sense (ability to predict consequences before actions) is extinct. The truth is that rampant stupidity (including on the bench) and laziness is the end result of our corrupt, myopic, politically subverted public education system misrepresenting the facts of life and requirements for civilized, peaceful coexistence combined with

coercions of unequally applied law, dividing perspectives away from common interest. This is, in actual fact, environmental control, different legal environments for different legally decreed classes of human beings (as the Nazis did to the Jews and others). This has the innocuous sounding label of "social policy", which creates much conflict between groups / defined classes of people in society from which government and law profit greatly by pretending to mitigate conflict of their own creation by abusing the power of law as a weapon against the civilized and civilization which is in the final stage of collapse into a war of all, against all.

This is regarding power, arrogance, corruption and illegal / immoral actions of criminal, ruling factions within the Governments of Canada, Ontario and Judiciary, imposing will of some men, enslaving others, all the way up to Supreme Court, abusing law as a predatory instrument of plunder, rationalizing away the basic laws that protect Canadians (including honest public servants) from criminals within government and without. These systematic, ongoing crimes and predations have been very costly to my family and Canadians and, the cumulative consequences of these crimes against many has placed Canada on a path to unsustainable debt to globalist bankers and social / economic collapse, a strategic threat to Canada engineered by enemies domestic / traitors. Government, as public servants are dependent on the productive and a productive economy to exist. Lose "consent of the productive" and, you lose your jobs and civilization plunges to barbarism. My basic messages are: you're fired, unfit to associate with, leave me and mine in peace. The overall social / economic facts indicate collapse of the economy and therefore Canada's suicide is nearly complete. Determined opposition, by all of us, an about face and major course reversal is required to avoid the collective doom we are being forcefully coerced towards.

Cease and desist your decades long illegal predations against myself, family and lawful peaceful affairs and compensate myself and family for harm done, or, myself and fellow Canadians will be forced to AGAIN physically defend ourselves, lives and property and undertake our historical and legal role as final line in the sand (defense) against tyrants with false rationalizations, claiming to be driven by social good, while in actual fact, acting as predators, collapsing peaceful division of labor (civilization) and being accessories to crime coercing a trend to another global war. Canada and Canadians (including my father and two uncles, one killed) have fought two world wars against tyrants with IDENTICAL behavior (stripping some by decrees of man of their humanity, equal rights and freedoms necessary to life as productive human beings, assaults on peaceful civilization, the civilized and rule of law). We also fought a very lengthy and expensive cold war and, our enemy; socialism collapsed by the economic unsustainability and loss of "consent of the productive", the same predatory folly that has now very nearly collapsed western civilization. The expected peace dividend of the collapse of the USSR and end of the cold war has been bait and switched to a third world war of terrorism (rationalized by claiming people that have been aggressed against, been forced into defense are terrorists, when they did not start the conflict), rapidly turning hot using the false pretext of freedom, where freedom is nowhere to be found in the west. We are being collectively forced to social / economic collapse because the rule of law and the necessity of controlling democratic excesses (governments exercising criminal powers that do not lawfully exist) and predatory behavior has been rationalized away.

The reason I APPEAR to be alone in opposing you is to AGAIN establish a basic, inarguable fact of life, civilization and reality: Profit cannot be made from servitude and slavery. If you pretend to pay us, we will pretend to work while diverting most of our productive energies to avoidance and defense. Freedom from predatory bullies can be more effectively fought for (and was historically won) by individuals representing common interest as opposed to myopic special interests fighting for a bigger piece of a pie they did not produce. Bear in mind that I have been effectively opposing tyrants for a very

long time. My enemies are also stupidly unaware of the extent of covert opposition they have. I am still standing, defiant as ever. I will allow my foes to keep their ignorance regarding who and what, if any allies and support I can call upon should they persist in these crimes and fail to end this matter to my satisfaction, immediately.

There are a lot of hungry ambulance chasers in the legal "profession", who would love to get a cut of the damages that these crimes has caused to my career, lawful rights and affairs, family and Canadians in general. Also, the facts and evidence in this matter is extremely well documented. There are many judges and lawyers who share the frustrations of myself and fellow sane (want to survive) Canadians, some very ambitious who would welcome the opportunity to deal with the root causes and legal subversions resulting in western civilization being in the final stages of succumbing to a predatory assault. It is the nature of predators to climb the food chain and, they are now at the top, destroying the rest of us. If the legal profession does not soon face the facts and get an objective grip, they will be correctly perceived as the cause, a target of retribution and not of use post collapse.

Further, I am after the individual criminals in this matter and will NOT allow the costs of reparations in this matter to be transferred my innocent fellow Canadians, as tax, making them pay for these crimes, an injustice. It is the individuals who made the choices that are personally responsible for their criminal behavior, not innocent taxpayers. If I am forced to sue the Government, one of the terms of settlement will be to immediately compensate my family, and criminally charge the individuals responsible for this matter and obstruction of justice, who have totally discredited the institutions of government and law. My enemies are individuals who have harmed and discredited our public institutions and Canadians, far more than my family, who I have protected to the best of my ability. Honest public servants, judges and I have inarguable common interest in this matter. You just need to favor facts and reality over doing your job and following process / orders as demanded by the Nuremberg laws stating the obvious fact that you are responsible for your own behavior and accessories to crime, should you not oppose criminals.

Judges are waking up to the risks to western civilization and dire consequences to their profession and, are being forced to AGAIN shift allegiance to the people and rule of law, away from those who coerce them to be assistant predators, enforcing a divide and conquer "social policy" by inequality under law. I can prove to objective judges that they do not want to face the historically proven consequences of proceeding on present course and have the rule of law and western civilization totally collapse on their (and my) watch.

To Re-iterate: Cease and desist your threats and aggressions against myself, family, Canadians and civilization in general, compensate for harm done. Obey the law as written and objectively interpreted, performing its function of predator control, protecting peace and civilization. Do your jobs as public servants, employees of Canadians, for the benefit of Canadians and NOT selfish interests or following process / orders as concentration camp guards, terrified of the survival threat (loss of job) should you use your brains and dissent. We are all personally responsible for the consequences of our own actions, and it is a well-established legal truth that following orders / process is not a valid excuse for criminal (harmful) behavior. I have, by objective fact, reason and law repetitively won all legal arguments in this matter, peacefully behaved in strict accordance with the stated goals and letter of the law, only to meet contrary judicial BUT's, dismissing fact, law and reason. The most plausible reason for the failure of reason and law in this matter is: "better me and my family be collateral damage (prey) than you" by refusing to follow orders / process, coercing us to social / economic collapse. I will not accept any excuses to the contrary regarding why we are slaves and you and your crony's master. I am far more

terrified of the consequences (repetitively proven by history, littered with collapsed civilizations, destroyed by predators / barbarians, within and without) of submitting to tyranny than opposing. Despite the hefty costs I have already been forced to pay (stripped of rights, harassed resulting in inability to pursue my engineering career), I am prepared to pay the ultimate cost, as our ancestors did, fighting tyranny. I may be destroyed, but in the process will contribute to the further erosion of your credibility and ultimately, determined sane people such as myself will AGAIN prevail in forcing governments to be public servants as opposed to arrogant predators and criminals with false pretexts of necessary evil, which in actual fact is not necessary, but is pure evil (profiting by harm to innocents, including all taxpayers).

### ***What's wrong with your perspective, why does this appear overly complex and confusing?***

Many who read this will be blinded by their myopia, educationally / media induced false assumptions, imprecise definitions of words and concepts such as freedom, fairness and justice, limited perceptions of reality encompassing short term selfish interests for themselves and their political constituencies, or, robotic cog in the machine of state and assume that I also am arguing a limited point of view, based on arbitrary opinion and my selfish interests. This is totally false. If I were selfish, I would have run long ago, abandoned my daughters to a horrible fate of wasted, ignorant, irresponsible lives, to preserve my cowardly self, rather than standing my ground to defend my family, country and civilization. I am informed by history, human nature (if attacked, must defend) and my excellent engineering education and former very successful experience as System Design Engineer restricted solely to the domain of civilized common interest (all equally benefit / pay), with tolerance for diversity in any area except causing harm to innocent others by any pretext / excuse. I am unambiguously stating and proving to you that, professionally (System Design Engineer) and personally, as a fully aware, moral (cause no harm) human being, the system of unlawful compulsions constructed by corrupt elements within the institutions of civilization that entrap all of us is going down, cannot be repaired (predatory behavior precludes functioning) and nobody, not even government and law will escape. Without an immediate and opposing course change, this is inevitable, just a matter of time for loss of "consent of the productive" to result in social / economic collapse and very likely, another world war, over irrational philosophy, dangerous forces seeking to be master predator, globally as opposed to acknowledging reality. If reason does not succeed, very few, if any will survive the coming planetary war.

### **On Legitimacy and Scope of Power, Governments and Law included:**

I and my fellow Canadians KNOW what legitimate law is, because to harm anyone, interfere with their freedoms, property or their peaceful affairs, or, in general to initiate force or fraud is NOT within the legitimate power of any individual or group of human beings, government and law included. Man and man's law does not have the moral power to decree who lives or dies, except in defense from aggressions. This is because of a basic, irrefutable fact of social life: To harm anyone creates conflict by the offense and legitimate defense, and, if not suppressed, results in an escalating tit for tat aggress / defense sequence, disturbing the peace that is required for peaceful division of labor, also known as

civilization. When conflict is allowed to escalate out of control by obstructing justice, this is called war. Historically and under honest law, those who rely on force and / or fraud to achieve their goals are classed as criminals, barbarians who, by their unproductive costs (harm) destroy civilizations and the civilized. The REAL function of law is, therefore: predator control required for the existence of civilization. Every single criminal law that exists such as robbery, theft, fraud, not keeping contracts (promises), assault, rape, etc. performs this function. Constitutions (also rationalized away) presume to define the relationship (respective powers) between governments and people.

The current function / behavior of law, has devolved to regulatory tax collectors (on behalf of unproductive addicts to arbitrary power) and to keep the peace by terrorizing and destroying anyone who refuses to be a slave or defends themselves from criminal aggressions. The reason that non-government criminals appear to be dealt with is to preserve the loot such that governments / law are the master predators and they are free to prey below the threshold that intolerance of the governed will be forced to act in collective self-defense. I am decades beyond intolerance and, it should surprise no one that when barbarians achieve control of government and law, it is civilized, honest people such as myself that are decreed to be criminals. Every single police officer and crown attorney I have approached regarding this matter claims to be working for (obeying) the government and not the people who pay their salaries.

I have also had off the record discussions with judges who have explained the nature of their process traps, preventing them from acting on penalty of losing their jobs. Most claim that they are attempting to mitigate the damages, which is the only reason they have not resigned in disgust, out of fear that they will be replaced by even more predatory judges. Many have given me valuable, off the record insider information which has allowed me to intimately know my enemies.

We, here in Canada live in a constitutional democracy and our public servants are selected and allocated a portion of the people's power, to administer the functions of state, including law, as employees, on our behalf. The source of the power of law and government is derived from "consent of the governed" WHO DO NOT HAVE THE LAWFUL POWER TO AGGRESS against their fellow human beings, possessing only defense from predator's power. Any power that government and law claims / exercises, if not possessed by their employers (the people) must be self-decreed and are enforced by OUR guns, an abuse of our power and property, pointed at us. As to falsely claiming that our ancestors and the laws they wrote place and keep us in servitude, they do not, for the same reason I rejected my parents control, left home at age 14, cared for myself and worked my way through school, seizing my own destiny and freedom. All of us, upon achieving age of majority are fully free from compulsion adults. I consider REAL law and limiting government to a solely defensive role against predators to be hard won historical knowledge, the basis of operation of near extinct western civilization. Further, I consider the hypocritical propaganda and rhetoric self-alleging the moral purity (smite some for the benefit of others) in this matter to be a false intellectual cover / adaptation of predators who have been historically forced by people such as me, fighting for and securing our freedom using the basic knowledge that freedom is not granted by anyone but individuals personally defending their own rights to peacefully exist and is a fact of life and peaceful civilization, to be respected, not given nor rationalized away. Freedom and peace must be eternally defended and maintained against predators.

Our highest laws state this, but they have been rationalized away by rule of greedy, unproductive men, enslaving others.

"Somehow" by false rationalizations too numerous and absurd to mention, government and law claim the power to aggress against peaceful, law abiding people and democracy has been turned into an instrument of plunder by pitting peaceful and lawful viewpoints against each other, creating a social / economic situation of warring special interests and conflict. The legal "profession", having created this problem, profits greatly by pretending to mitigate conflict of their own creation by rationalizing away the "rule of law" and the equality of treatment for all human beings requirements within. Honest law used to call keeping law and government within their legitimate scope / role of defense of peace and civilization as "controlling democratic excesses".

The democratic will of Germans manipulated into Nazi "get the Jews" and "final solutions" is an inarguable example of the costs when "rule of law" is subverted and rationalized away to rule of corrupt man, resulting in tyranny. Nazi judges were hung for their rule of law violations, decreeing some people as subhuman, enablers and accessories to crime in the tyranny. Currently, in Canada and the west in general, similar "rule of law" violations have resulted in a total political war between the entitled and productive, rapidly converging to social / economic collapse and civil war, under coercion of social manipulators, rationalizing that some are more special than others who must be slaves.

I am under no illusion that this is a fair (same rules for all) fight, but do intend to remain fair and prevail by clean hands, occupying the factual, truthful, moral and legal high ground. The basic fact is I have been and remain respectful of true law and the legitimate interests of my fellow human beings, while law and government has been seduced by absolute power corrupts, absolutely, becoming tyrants.

## **How most are manipulated, in a basic philosophical trap, at heart of Canada`s and western civilizations destruction:**

Philosophy is a set of assumptions, many unstated (and historically disproven) and logical implications from which a restricted perspective of alleged or desired reality is asserted and, many are blinded by philosophy, so thoroughly and dogmatically that contrary evidence is strategically denied and truth tellers are persecuted or destroyed. Philosophy, including political, economic and religious blinds believers to the nature of provable action precedes consequence physical reality. It is a FACT that adaptation / compliance to facts and proven reality is the key to survival, individually and collectively. Ignoring facts and reality invariably results in doom for individuals and civilizations who blindly march to philosophies misrepresenting provable reality. Those who seek to rule, control and enslave others NEED philosophy to rationalize their actions, to keep people ignorant, divided and confused. The entire political pseudo-science "profession" is dedicated to creating and marketing philosophies rationalizing rule of some men, enslaving others (arbitrary rulers), contrary to the requirements for peaceful division of labor, civilization and freedom.

The Nazi tyranny came to be because Germans were looking for somebody to blame and an explanation of why they were economically suffering. The Nazis created a philosophy that scapegoated and blamed

Jews and other alleged subhumans to fill this role and offered final solutions under the banner of "Get the Jews". Germans voted the Nazis into political power resulting in very expensive consequences (and great profit, for some), a second world war, consequence of the first which enslaved Germans and much death and destruction. Basically, Nazi and all philosophies of rule are pretexts / excuses regarding why "rule of law" and equal treatment of all human beings under law should be violated. The atrocities of WW2 ended the ability of political philosophers to plausibly make discriminate against any group for the alleged benefit of others "arguments", at least among the intelligent and morally aware. This fact is encoded in Canada`s anti-discrimination laws, a major hit to tyrants.

The refuting of Nazi philosophy did not mean an end to rationalizers for arbitrary power, it just meant that they had to find other pretexts (excuses) to prey, since "cause harm to some, for the alleged benefit of others" as a method of securing political power over others can, hopefully, never occur again so long as we are vigilant. Since the goal of political philosophy is creating plausible and perceived morally valid pretexts to prey and preying is non-negotiable, some new excuse was required.

Some wit came up with the current "solution"; Rather than stating "destroy someone" as an excuse for predation, use "help the alleged unfortunate" as an excuse to acquire power and resources from some for the alleged benefit of others who are made dependent slaves, with no reason to be productive and contribute to civilization. The sheer evil beauty of this Nazi pretext swap, rationalizations for the behavior of oppressing some (the productive) for the alleged benefit of others (the unproductive, alleged needy, mostly lazy). Different pretext, same predatory behavior required.

These positive rights (entitlements) have been illegally encoded into the laws of Canada and are in direct opposition to rule of law, property rights and the peace and freedoms that Canadians have historically fought and sacrificed so much for. It is strategically denied that without property rights (fruits of labor), no peaceful division of labor is possible and, who gets what becomes a matter of great conflict, a matter of opinion, with no stable resolution, just an eternal king of the hill war, where to become king allies all in opposition, toppling the king. If there is no reason to labor and becoming successful only attracts predators (this matter is exhibit A), well, why labor and contribute to civilization? This is the situation that I have been illegally entrapped in. I could not and cannot be productive due to the conflict it has and does attract from rationalizing predators who believe that their self-alleged wisdom and mere words and opinions are superior to property rights (reason for choosing to be productive) for those who actually do contribute to civilization.

This contradiction between rights / freedoms and their exact opposite, alleged positive rights and entitlements is a useful philosophical trap for government and law. To choose / enforce rights / freedoms violates entitlements. To choose entitlements violates rights / freedoms. This is a contradiction (philosophical trap) that cannot ever be resolved with the benefit of creating much conflict for the legal profession to profit from at the expense of peace, productivity and civilization. Objective, unambiguous law no longer exists (therefore, impossible to know or obey the law, a moral hazard trap) because of this contradiction. Judges, up to and including the supreme court can and do use judicial discretion (rule of man) to violate any and all rights / freedoms under the false pretext of altruism, helping the unfortunate with the real consequence of making people dependent slaves, voters for more

entitlements and arbitrary power. The law is complicit in the crime of replacing rule of law with arbitrary rule of man, historical destroyer of civilizations.

Demands on government / law for entitlements can, based on their perceived self-interest either be agreed to or denied on the basis of violates someone's rights.

Demands on government / law for human rights can, based on their perceived self-interest either be agreed to or denied on the basis of violates someone's entitlements.

Note that, on a case by case basis, government and law can, by rule of man, judicial discretion choose / do whatever they want as arbitrary rulers between the conflicting polar opposites of historical rights / freedoms and entitlements and claim to be acting legally, without contradicting themselves using law as a reference of truth, since it is the law itself, with opposing goals that is contradictory and, therefore false.

For honest members of government and law, it should be apparent that there are very dangerous enemies within your ranks, intent on profiting by collapsing the civilization that you are oath bound and employed to defend. One of my goals in this matter is to ignite a civil war within the state and judiciary, to deal with the psychopaths who have manipulated themselves to be in control. It may be risky to dissent, but it is certain doom in social / economic collapse and pitchforks and torches from me and my fellow citizens if you do not, an inarguable, no exceptions historical response to tyranny destroying civilizations.

The judiciary is also in another trap, another logical contradiction, which they freely admit:

"Not only must justice be done, but the perception of justice must be maintained" This cedes power of objective law to those who establish subjective perception: Subverted education and media.

## **Why Income Tax (Servitude) is and must remain Voluntary:**

Historically (thanks to our freedom fighting ancestors), Canada had no income tax and government was minimal, funded by tariffs and charging for service provision, all of which could be avoided since forceful compulsion / servitude was and still is illegal. For WW1, voluntary income tax was instituted under the pretext of "paying for war" within the context of a patriotic media campaign, and, over a century+ of cumulative miseducation, fraudulent utterances and outright intimidation, Canadians became Pavlov conditioned and educationally subverted to consider income tax as an inarguable fact of life. The basic legal and real truth of income tax (on fruits of labor) is that you must spend a portion of your life to pay it, making you a slave for whatever portion of your life you are compelled to toil to pay taxes. Slavery and forceful compulsion is illegal. It has taken a century+ for arbitrary power's addiction to income tax (servitude) to destroy productivity in western civilization, collapsing civilization, as we are experiencing, here and now.

Basic law is very clear regarding income tax being voluntary:

a) You cannot be compelled to file a personal tax return (or to do anything, apart from cease aggression and undertake responsibilities for your actions, including caring for yourself and children). If you sign a tax return, this is a legal contract, you have volunteered to be taxed, and by signing a tax return, you are swearing that it is a true statement of fact and, it may then be legally interpreted to convict you of fraud or used to harass and legally impoverish you in the defense, even if you were truthful.

b) If you do not volunteer to file tax returns, the law states that unaccountable (to electorate) bureaucrats at Revenue Canada can decree (an opinion) what they allege you owe and, their salary depends on this. They freely admit their decrees are highly inflated, to coerce you to "volunteer". This is rule of man and, there is no written law that equates this stated opinion to law. The existence of such a law would state that arbitrary opinion from government is law, making the judiciary into rubber stampers and, tyranny would again be firmly established.

c) Another reason that income tax is voluntary, able to be refused at will is that people, by withdrawing consent (consent of the governed, a crucial requirement for government survival) , can keep government and law honest, acting in the peoples behalf, public servants by controlling the purse strings. When government and law become tyrants (as in NOW), running amok, we, the people can legally withdraw the resources they need and use for predatory behavior, causing a peaceful de-escalation and states returning to behaving in "common interest", as opposed to serving special interests. Without this possibility for peaceful resolution, the only possible response to tyranny is massive civil disobedience, conflict and civil war collapsing civilization. Government and law need to be controlled, kept on the straight and narrow of predator control, since history is very clear: absolute power corrupts, absolutely and government and law are, by their nature, incapable of controlling themselves. That is the people's responsibility.

d) Further, I have repetitively demanded "show me the law" in the matter of equating arbitrary decrees and compulsion to force of law, only to meet deafening silence. There is no law, only enforced false opinions of some that we are slaves and they, master using OUR guns to enforce their "might is right" opinion.

These irrefutable factual and legal arguments have been repeatedly made by many others ever since income tax was rationalized from voluntary to enforced involuntary, only to be strategically denied by the courts, opinions of biased, arrogant men who claim their opinion is truth, superior to established facts and reality. Since the courts receive their salaries from income tax revenue, they are accessories to crime, coerced by their salaries to enforce servitude and hopelessly biased, a trap that honest judges should never have allowed, since their dependency (servitude) is destroying them and their profession by being accessories to crime. Any judge considering this matter must dismiss himself by reason of conflict of interest.

I do not expect government or law to agree with the legal and larger survival of civilization facts of this matter. The instant that this matter escalates and force is used against me or my property, this becomes a matter of defense of life and criminal law, which I expect will also be complicit.

Further, I expect the claim that property rights do not exist to be used to seize my property. This is an

assertion that those who seize my property or whoever they allege is to benefit, do have property rights, which supersedes the property rights of those who actually spent a large portion of their lives contributing to civilization earning it by productive activity. This is a clear violation of the equality of treatment provisions of the rule of law, an allegation that some have rights that others do not. Further, this is a subset of Nazi legal philosophy that I am subhuman and can be stripped of rights, for the alleged benefit of others, with a hefty commission to the redistributors.

## **If Income tax is NOT legally respected as voluntary, why I still cannot be legally or physically compelled to pay it:**

Nobody can force me to be a taxpayer / slave, paying for enforcement of my own servitude and destruction of civilization, since I am not a slave and will oppose all dissenters. The best anyone can do is forcefully subdue and possibly kill me for resisting while your agents steal my home and property, evicting my wife and I to the street. It is truly terrifying that a large percentage of my totally miseducated, propagandized fellow Canadians will vote and cheer you on to protect their entitlements (and your jobs, entitlements, creating, enforcing irresponsibility) at the expense of the nearly extinct productive, those who actually try to be personally responsible, pay your salaries and contribute to the economy, as I did prior to being assaulted and bushwhacked by criminals and my productive energies diverted to defense of self and daughters from corrupt judges. Similar cheering crowds were present in Nazi Germany, as they "got the Jews".

The facts of this matter are clear. Corrupt elements within government and law used my previous (and very substantial) tax payments as resources / weapons to aggress against me and my family causing great harm to all concerned, including my ex-wife and fellow Canadians by costs of these predations, paid for by taxes. My right to life and duty to protect my family, when threatened and aggressed against allows me a proportional defense against aggressors, whoever they may be, where proportional is defined as: enough to stop the aggressions and no more. If my predators appear about to destroy my life, well my necessary and legal proportional response allows me to destroy them. Thus far, my chosen, far less than proportional, peaceful response is to not provide taxes for the resources and weapons that have and continue to be used against me, my family and fellow Canadians. It is my right to life to not assist my enemies who have defined themselves by initiating aggression.

Thus far, I have been protected by my intellect and adherence to my basic moral values which have prevented me from being violently provoked and kept me within the realm of non-violence and honest law:

"Be neither predator, nor prey, nor, if within my power allow anyone else to be so." I am a peaceful, civilized, morally aware human being. There are no counter examples of me behaving contrary, for my entire life, despite my ex-wife's false allegations of abuse during divorce proceedings.

The reason I have not yet been smited is I have not yet allowed myself to be provoked into physical resistance which will be spun by corrupt law into the crime of initiating aggression, rationalizing away who started it and denying that my actions were defensive. I have peacefully resisted, within the bounds

of true law. To smite me at this point is too blatant, since the collective lobotomy of subverted education, Pavlov conditioning the false belief that law and government is god, determining who lives and who dies is not yet complete. The scales of justice balance "equal right to choose life among individuals" not balance of political opinions, favoring some, preying on others.

The law will have a hard time misrepresenting my zero aggression behavior to be a crime. My divorce records are littered with their failed rationalizations regarding why peacefully refusing to be a slave and allowing my daughters to be harmed harms anyone but tyrants and their dependents.

There are only five possible responses to aggressions against self and family and the productive parent being forcefully enslaved and evicted from their children`s lives:

a) Tolerate it, allow the damages to occur, be a slave paying welfare, socializing your children to irresponsibility and entitlements in the absence of a personally responsible role model parent and relieving the government of politically paying the costs of their promises, welfare / appeasements for irresponsible parents and people in general.

b) Allow yourself to be provoked, blame it on your ex-spouses lies, physically harm or kill her. End up in prison, feeding the abusive male and spousal abuse myths, which are both really provoked male consequences.

c) Run away, abandon your children, feed the deadbeat dad myth which is really a consequence of enslaving fathers, exercising flight as opposed to fight.

d) Commit suicide due to inability to cope with servitude and being powerless to help your children. Many have.

e) Do your moral and legal responsibility as parent and human being, despite all opposition, as I have. Be determined that "crime does not pay / succeed".

Until this matter is sorted out, to my satisfaction, I intend to NOT pay for my aggressors to have the means / resources to continue aggressions. That is aiding and abetting enemies of civilization and forcing me to behave to the detriment of my right to life and legal, moral obligations to fight tyranny, tooth and nail, independent of costs, else be complicit in their crimes, as stated in the Nuremberg laws, to which Canada is obligated and under which Germans were collectively punished for being accessories to Nazi crimes.

Article 39 of the Magna Carta (1215 version), reads, "No free man shall be taken, or imprisoned or dispossessed, or outlawed, or banished, nor will we go upon him, nor send upon him, except by the legal judgment of his peers or by the law of the land." Intelligent, morally aware people, fighting for freedom, secured the Magna Carta eight hundred years ago which was a limitation of arbitrary power by the intelligent and reasonable and the beginning of rule of law for western civilization. Rationalizing away the rule of law has placed western civilization on a path to destruction and chaos by arbitrary decrees of man, fraudulently misinterpreting law. The significant damage already done to my peaceful, lawful affairs and force being threatened against me is unsupported by either the legal judgment of my peers

or, the law of the land.

I hope you fools are beginning to perceive that you would much rather have competent people such as me, with you, as opposed to against you. Since this situation is based on no valid law, the correct thing to do is to develop sanity, admit defeat and un-decree of man all of these crimes away and compensate myself and family. Further, your current political support is the appeased unproductive. Inevitable economic collapse will end this and your current support base will become bait and switched mobs in opposition. This also, is history.

If you believe that the law is on your side in this matter, bring it on, charge me with some absurdity for doing what human beings have been forced to do for all of history: protect their families, property and peaceful affairs from barbaric predators with "might is right" excuses. Otherwise, immediately get out of my life and affairs and compensate my family including my ex-wife (a pawn, advised by her lawyer to lie, her life totally destroyed in pursuit of entitlements, when a simple acknowledgement of written law regarding her personal and legal responsibilities could have saved her and avoided all this collateral damage) for harm done.

And, since the Justice Department and judiciary are in strategic denial regarding what justice and fairness actually are, I will provide the REAL, historically proven definitions:

Justice Defined: We are ALL responsible for the consequences of our own actions, good (we own what we create, contribute to civilization) or bad (compensate for who / what we destroy). This means peace, security and property rights for the peaceful and productive, sanctions and reparations for criminals.

Fairness Defined: Same rules for every human being, a level playing field.

In general, this matter is part of a systematic assault on personal responsibility within society. If people are not personally responsible, they become dependent (slaves) to those who provide their basic survival needs. Only personally responsible people can be independent and free. Strip the rhetoric and false pretexts in this matter away and, the result is: My refusal to be complicit in these crimes, to have my property stolen to make me a dependent slave is an assault on freedom. This is not rocket science. It is an attack on the basis of operation of western civilization resulting in inevitable social / economic collapse. I will not, to the best of my ability, tolerate this to happen on my watch as my tyranny fighting ancestors also did. What little freedoms we have left are thanks to their sacrifices.

## **What does the Government of Canada allege the law to be?**

This is directly copied from the Department of Justice Website. **Bold is original**, *Italicized portions are mine*.

### **Why we need laws**

**Laws are rules made by government that forbid certain actions and are enforced by the courts. Laws apply to everyone equally. If you break a law, you may have to pay a fine, pay for the damage you**

**have done, or go to jail.**

*Salient Points: The nature of valid law is restrictive of actions that cause harm, applying equally to ALL. Valid law is restrictive and NOT compulsive (servitude) whether it is applied equally to all, or selectively. The purpose of valid law is defense from harmful actions. Law's legitimacy come from our rights to defend from aggressors, a portion of our personal power transferred to government by democratic mandate. We do not have the legitimate power to be aggressors, so CANNOT transfer this power to governments. Further, government is composed of individual people, prohibited by law in their individual and official capacity from being criminals.*

**The law provides a way to resolve disputes peacefully.**

**Imagine the chaos – and the danger – if there were no laws. The strongest people would be in control and people would live in fear. Drivers could choose which side of the street to drive on and no one could stop them. Imagine trying to buy and sell goods if no one had to keep promises. Or trying to hold onto your personal property or even to keep yourself safe if there were no laws against robbery or assault.**

**Our laws also recognize and protect basic individual rights and freedoms, such as liberty and equality. Even in a well-ordered society, people disagree, and conflicts arise. The law provides a way to resolve disputes peacefully. If two people claim the same piece of property, rather than fight they turn to the law. The courts can decide who the real owner is and how to protect the owner's rights.**

**Laws help to ensure a safe and peaceful society. The Canadian legal system respects individual rights and ensures that our society is orderly. It applies the same law to everybody. This includes the police, governments and public officials. All of them must carry out their duties according to the law.**

*Salient Points: Robbery and Assault are against the laws that all must obey. Disputes are resolved by the courts. No mention is made regarding how the courts decide property rights when, within society, property rights are established by earning property by honest trade and labor. Revenue Canada refuses to charge me for breaking alleged laws that do not and cannot validly exist. To sue the government to obey the law takes more resources than even wealthy Canadians can afford.*

*Note that the above government statements of law and justice are what all Canadians believe and, I am fighting for them to obey. Thus far, impoverishing litigation has resulted in, "yes, BUT (insert fraudulent social engineering excuse here).*

## **Academically Speaking**

My general conclusion in this matter is this absurd situation is created by social manipulators fraudulently calling themselves social "engineers", an insult to my profession. These manipulators pit peaceful viewpoint against peaceful viewpoint, an assault on personal responsibility, to make me and my fellow citizens dependent and, therefore slaves. It is a sideways assault on freedom, because without personal responsibility, in a state of dependency, there can be no freedom. Academically, tyrannical behavior regarding destroying personal responsibility and making people dependent are key recommendations of the "Communist Manifesto" (historical enemy of Canada) and Machiavelli, "The Prince" (advice to arbitrary rulers, bible of politics). It is also a pretext swap from Nazi "get the Jews" to "help the unfortunate", all of which require the same behavior: Prey on some for the falsely alleged benefit of others, with a hefty commission for tyrants with false pretexts, contrary to the equality of treatment provisions of rule of law.

Whining to authority to give you freedom is believing they have the power to control you. Because we live in an action PRECEDES consequence reality, it is a natural right (laws of reality which ultimately

smites all who fail to comply) to be free. We can do (choose) whatever we want to do. The only choice of others is the choice they make in response. We can be punished for our choices, but no one can prevent them unless we are incarcerated, mis-educated or terrified by fear of consequences. Historically, honest law had a single response: smite those who initiate aggression, cause harm, disturbing the peace, harming civilization. Leave everyone else alone, in peace.

## **Brief History of Initial Assaults on myself and family (corrupt divorce courts)**

Until 1996, I was a highly successful engineer at Nortel, technical lead designer of my division, leader of teams designing very successful products that kept factories in Canada very busy, with many high paying manufacturing jobs and millions of dollars of tax and export revenue, paying punitive taxes.

I was then bushwhacked by corrupt divorce courts which, contrary to fact, evidence and law decreed that my irresponsible, alcoholic, with zero interest in our daughters (I was dominant caregiver during marriage, ex-wife had no clue how to deal with or meaningful relationship with daughters during psychological observation and final report recommending custody to myself, by the facts repeated here). The only interest of my ex-wife had in the marriage and our daughters, to date, appears to be their economic (secure alcohol, life of Riley) value. The courts decreed that my ex-wife was a better parent than me because my intelligence, personal responsibility, freedom values (speculated abusive, false allegations of abuse, would emotionally damage the little darlings...) were not values that they (or, government in general) wanted taught to my daughters. The last thing that irresponsible governments wants is responsible citizens such as I, opposing them. Contrary to clear law (Divorce Act, stating children's best interests are paramount) and irrefutable evidence, including my ex-wife's family in support of the facts regarding my ex-wife's irresponsibility, addictions and unfitness as a parent, I was decreed a support paying slave, kicked out of my parental role, with zero influence, including educational and trapped in the position that I was being forced to pay for socializing my daughters to welfare mentality, with no personally responsible, nor intelligent, caring role model / parent. I was placed in a trap, forced to pay for my ex-wife's addictions and to socialize my daughters to entitlements and irresponsibility, as my ex-wife's parents' divorce manipulated / socialized her to believe that motherhood is a paid babysitting role, as opposed to legal responsibility and the purpose of fathers is to be slaves. My ex-wife fraudulently entered into marriage by misrepresenting herself and pretending that she wanted to be my partner and was willing to work towards family, as opposed to her irresponsible goals. This was not a situation that I, or any intelligent, morally aware person could possibly tolerate. I had so many woes, and worries regarding my ex-wife drinking and driving with my young daughters and emotional abuse / neglect of my daughters that I could no longer function in my job and every day I worked only contributed to the harm to my daughters, subsidizing a Potemkin mother and harmful role model that could only doom my daughters to be as ignorant and irresponsible as their mother.

I quit my engineering job because I was incapable of paying attention, crippled by worry for my daughters and was in a position of trust to cause great economic harm to my employer by inevitable mistakes. I rejected psychiatric leave, unemployment insurance and social services since they would

have made me dependent and eventually a slave. Having been deprived of all financial resources, I lived for free in a friend's basement and existed by selling personal property, then started a corporation, consulting, to best of my ability, hampered by my driver's license being taken away as "deadbeat dad", precluding business trips, and potential clients being harassed / alienated by private investigators, slandering me as a deadbeat father, paid for by legal aid (my taxes). My ex-wife had, at taxpayer expense, unlimited legal resources to represent her and her lawyers' lies. In fact, as of 2007, this matter has been estimated to have cost taxpayers approximately [\\$6.5 Million dollars](#), including \$120,000.00 that her lawyer charged legal aid (taxpayers) to present her lies to the court, all of which were instantly disproven and no perjury nor obstruction of justice charges were allowed. These costs to Canadians have only increased, to date.

An unanticipated consequence of me quitting my job resulted in the proceeds of crime drying up in this matter with the consequence that my ex-wife and the law lost all interest in my daughters and I was able to raise them as a single parent, without significant interference. During this period, even though I was caring for my daughters, full time, I was still legally harassed as a deadbeat father because my ex-wife was fraudulently claiming that she was caring for my daughters and I was the deadbeat. My ex-wife received all social services and family allowances, of which I have never received any. This ended when my daughters, in response to their mother's manipulations, on their own insistence went to social services to inform them of the truth and demanded they leave their father alone. Social services declined to charge my ex-wife with fraud, since without clients; they have no jobs to pretend to be helping people.

Both daughters are now personally responsible, university educated, highly successful, contributing (and taxpaying) members of society, by the role model, stable environment I provided and the values / skills I taught, which allowed them to put themselves through university. Oldest self-employed in Toronto. Youngest is Aerospace Engineer (rocket scientist). A credit to any parent and an accomplishment that even most intact families fail at. My ex-wife has been on social services in one form or another since 1994 (lost her job two weeks before first divorce court hearing, to maximize entitlements), still a chronic alcoholic, compounded by medical "help" which has addicted her to prescription drugs on numerous occasions. My daughters are both alienated from their mother by a consistent history of her abuses, manipulations and lies.

Nortel and all the jobs and prosperity for Canadians no longer exists. The officially stated cause was fraudulent stock manipulation by management, which is actually a symptom. This is a lie. I was there and observed the demise. Nortel collapsed because punitive taxation drove our best and brightest out of Canada (brain drain), who also took Nortel IP and trade secrets to international competitors. Projects were failing left and right due to lack of talent and cost overruns. The financial hemorrhage of failed projects and no longer being able to design and sell quality products forced management into stock manipulation (fraud). If you cannot survive by honest trade, force and fraud (criminal behavior) are the only remaining options. Nortel was consumed by the legal "profession", a huge loss to Canadians and the Canadian high tech industry which has still not recovered and, perhaps never will. To add insult to injury, the military (most unproductive / destructive endeavor known to man) is taking over the main Nortel complex in Ottawa. The symbolism of current trend of barbarians prevailing over the productive and civilization of this does not escape me.

## **Timeline of Personal threats / Harassment by Revenue Canada**

Once my daughters were self-sufficient and no longer at risk should I be "taken out" (divorce courts

already proved that children are acceptable collateral damage in the culture wars for entitlements), I informed Revenue Canada and various government departments by registered mail on [January 21, 2007](#) that, effective immediately, I would no longer, as a matter of self defense be submitting personal tax returns, nor volunteering to pay personal taxes. The response, apart from cancelling support payments and returning my driver's license was and remains "obstruction of justice". The facts of this matter have not changed a bit since first exposure to the courts in 1994.

After ten+ years of scrimping and saving, I bought a home with my second wife on July 17, 2009, which predictably has been perceived as low hanging fruit, a seizeable asset by my predators. The only thing I owe my oppressors is consequences for their criminal actions is as big a kick in the tender bits as I can administer, a defense sufficient to stop these crimes. Prior to not having siezable assets, Revenue Canada and other instruments of the state were basically ignoring me, as unworthy (or more precisely, nothing siezable) prey.

This changed on July 19, 2010, when I received a series of arbitrary decrees of tax debt from Revenue Canada, for tax years [2004](#). [2005](#). [2006](#) and [2007](#) totalling \$20,541.67.

On July 31, 2010, I followed due process and filed a [notice of objection](#) to the above alleged debt, by reason that it was and still is an arbitrary decree, taxation is voluntary and, by reason of self-defense of my taxes being used as a weapons to destroy myself and family, this was my selected proportional defense, remaining as peaceful as possible. Legally, a proportional defense allows me to break any and all laws against my aggressors, so long as it is sufficient, but no more to stop the aggressions.

On [October 5, 2010](#), I received notice from Revenue Canada acknowledging my notice of objection, which contained the telling admission: "**Your correspondence contains a request for relief that can only be granted through the exercise of Ministerial Discretion**". This phrase admits and conforms what I already know and have proven; that income tax is voluntary and is a matter of decree of some men, enslaving others, requiring consent and IS not valid law. There are only three ways to interpret this telling admission:

- a) If income tax were a matter of law, then Ministerial Discretion, like all of us would have to obey the law, no discretion possible. Conclusion: no law in support of compelled income taxation.
- b) If income tax were a matter of law, then Ministerial Discretion, apparently, is above the law, able to oppress / reward who they choose.
- c) If income tax is NOT law, then, Ministerial Discretion falsely alleges, to be the law. This is what I claim: rule of some men abusing the apparatus of state and law are fraudulently misrepresenting law.

On [March 16, 2011](#), I received further notice from Revenue Canada again conforming that their assessments are arbitrary (opinion) and requesting that I voluntarily submit income tax returns as part of my appeal. What do you not comprehend, regarding "do NOT volunteer" to aid and abet my oppressors?

On [May 11, 2011](#), Revenue Canada sent notice that, after careful consideration, my appeal was denied and their decree of man (as opposed to law) alleged opinion of my debt stands. On June 28, 2011, I received final notice that the appeal was denied and suggested that if I have issues, take the matter up with the Tax Court of Canada, which is solely concerned with tax regulation and not human rights. This is a totally absurd situation. I complain to my public servants, elected to serve the interests of Canadians that our courts are corrupt and am advised to take the matter up with the courts?

On [April 26, 2011](#), by Registered mail, I sent notice to the Attorney General of Canada, again outlining

these crimes and damages, with evidence, that have been imposed on myself and family and clearly stated that it is my intent to remain in civil disobedience of their arbitrary, unlawful demands. The response of the Attorney General ([May 18, 2011](#)) was my complaints regarding corrupt courts and my legitimate defense from, were not a concern of the Justice Department, but, rather a matter for Revenue Canada, a clear obstruction of justice.

I contacted my elected MP regarding these criminal issues and received a response on [September 15, 2010](#) and was informed "not my job and, further, for me to demand he do his job of representing the interests of Canada and Canadians is interpreted as threatening and to cease further communications". I acknowledge that to oppose the predators that have corrupted government and law is threatening to myself and any who may assist me and has been the state of affairs for all of known history.

Legally speaking, just as concentration camp guards in Nazi Germany claimed to be innocently following orders / process, to be part of an integrated predatory system, where the parts have restricted perspectives, where the actions of the parts have the separate surface illusion of legitimacy but the behavior / effect of the whole is predatory is no more than a fraudulent illusion rationalized by false claims of social good. Reality is provable action leading to provable consequence, not word games by sophists, manipulating fools and themselves. The reality that has and is being forcefully imposed on all Canadians, myself included is: Servitude, a fact that can be falsely rationalized, but not hidden.

This matter was referred to National Collections and, on [October 15, 2013](#) a notice was sent to my bank demanding any and all of my assets. They secured a whopping \$76.40 and by [November 13, 2013](#), interest and penalties on my decreed debt added up to \$24, 176.12.

On April 22, 2014, other requirements to pay were sent to various other financial institutions. I was forced to close all of my bank accounts. I have been decreed person non-grata, my freedom to contract and associate violated, kicked out of civilization (division of labor) and have zero credit rating, despite the fact that none of my legitimate creditors have ever had an issue with me meeting my contractually agreed obligations, although the divorce courts nearly drove me to bankruptcy at the time.

On [10 June, 2014](#), I received notice that my decreed debt had been referred to the Federal Court, with a warning that "it MAY be necessary" to seize and sell some of my assets. Notice the ambiguous terminology attempting to hide the fact that THERE IS NO LAW allowing anyone to seize my property, except for creditors who have experienced default on my part, under an agreement with evidence that I have consented to the agreement and defaulted. The alleged debt in question is a decree, lacking consent and, in fact, it has been repetitively and clearly stated and documented "I DO NOT CONSENT". I received further notice, on [November 17, 2014](#) that a [lien](#) had been placed on my fully paid home, my only significant equity and my Canada Pension and Unemployment Insurance (I have not used ANY social services, in my entire adult life) are also subject to garnishment and reiterating that "we MAY proceed to seize, sell some of your lands, goods and assets". Note that if MAY were replaced with WILL, this statement goes from an ambiguous to unambiguous threat and fraudulent utterance, both illegal. If any of my property is stolen as a consequence of arbitrary decreed (no consent) tax debt, under our voluntary income tax system, this becomes a crime, despite what contrary rule of man judicial opinion has or may state, since this law does not and cannot (compulsion illegal) exist, translating decrees of man into rubberstamp law.

On June 11, 2015, I received notice from Revenue Canada that further arbitrary assessments for taxation years [2009](#), [2010](#), [2011](#), [2012](#) and [2013](#) had brought the arbitrarily decreed debt, interest and penalties

up to a total of \$40,230.97. Taxation year 2008 was not included, since my accountant, against my express and stated will accidentally submitted a return for 2008, which is invalid, since I did not sign, nor consent.

It is clear, that if there were a real law, translating arbitrary bureaucratic decrees of debt / servitude to force of law (which must treat all human beings equally and cannot compel) that tolerating arbitrary decrees of man is a nuclear weapon that can be and is used by those who control the apparatus of state and law to destroy any and all opposition, political included, independent of whether taxation is voluntarily submitted to or not. The intent (goals, effects) of my enemies has been consistently clear: destroy my ability to survive or to function as a personally responsible, productive member of society, for the alleged crimes (civic duty) of defending my family from predators and insisting the carnage against families by corrupt divorce courts cease, immediately.

People wonder why stupidity reigns supreme in society and we are headed for anarchy, war of all against all. It is because intelligent, civilized people, such as me who acknowledge the supremacy of fact, reason and rule of law are perceived and treated as very dangerous enemies to arbitrary power and are to be destroyed, marginalized, kicked out of civilization. Can anyone seriously believe that these crimes are to the benefit of any but corrupt elements among our public servants and judiciary, to the detriment of Canada and Canadians? I do dare call it TREASON.

Thus far, no action apart from threats has been taken to seize and sell any of my property (and these are phrased as MAY and MIGHT, with the word WILL carefully avoided. To use WILL in these threats is a real threat, contrary to law preventing compulsion). I am aware that others have experienced the misfortune of having their property seized under our voluntary income tax system, but, they were foolish and volunteered (contracted) to pay taxes by signing tax returns, and, most likely were accused of fraud by misrepresenting facts. In my case, I have volunteered and consented nothing, and, therefore, there is no contractual agreement to enforce between me and those who persist in destroying my life, ability to pursue my career and peaceful, lawful affairs.

If Revenue Canada disagrees with these basic legal facts, bring it on in a court of law. If you proceed to illegally seize my property, and evict my wife and I to the street, I have a legal right to a proportional defense from my aggressors and, your escalation increases the legitimate proportionality of mine. Further, since justice remains obstructed, I will be well within my legal rights to take justice in my own hands, since nobody else is enforcing it.

Thus far, apart from the illegal lien on my and my wife's home, a portion of my arbitrarily decreed, alleged personal debt, we are at a stalemate. I suspect you are hoping that my daughters, when I die will pay this lien to secure the dregs of their paltry inheritance. This is ironic, since all of these crimes against my family were falsely rationalized to be for the alleged benefit, best interests of my children, and, it is they who have suffered and will continue to pay the costs of your predations.

## **Escalation to Illegal Acts Against my Corporation, a Totally Independent Legal Entity (individual)**

Since Revenue Canada has failed to overcome my determination to defend myself, family and country from arbitrary, lawless tyrants by not providing resources to my enemies (defined by their initiating and continuing aggressions and threats) who have systematically and illegally aggressed against myself, family, peaceful affairs and common interests of all Canadians, apparently, Plan B was decided. Plan B is

to illegally attack my consulting corporation, which has, thus far, been scrupulously and provably in compliance with all applicable laws, including tax payments. Apparently, since my corporation provides me minimal income (my reputation destroyed in this matter, too much time and energy, life spent dealing with defense to keep up with my profession and scientific advances, clients hard to find), it was decided to destroy my ability and freedom to even have basic economic survival by illegally attacking and collapsing my corporation, a separate, totally independent, innocent of any law-breaking legal individual. I interpret this act for what it is: predators attempting to move up the food chain.

On [February 10, 2014](#), My Corporation, Bill Ross Enterprises, Ltd. received a requirement to pay notice from Revenue Canada demanding that any and all payments due to Bill Ross, the individual, decreed tax debtor, be diverted from Bill Ross to Revenue Canada. Upon consultation with Bill Ross who disputes this decreed tax debt, Bill Ross Enterprises Ltd. decided to stay out of this difference of opinion dispute and, not be an agent for tyranny, else also be complicit in these clearly proven, but strategically denied crimes and legally liable. Further, the only significant asset of Bill Ross Enterprises Ltd is the skills of Bill Ross who hopefully, will soon be allowed to be productive, or end up fired. A seizure and sale of the assets of Bill Ross Enterprises will yield very little, since it is composed of mostly obsolete computer equipment. Without Bill Ross being able to focus on work, Bill Ross Enterprises is heading for bankruptcy, just another innocent collateral damage in the political wars between the productive and unproductive which has also driven the best and brightest out of Canada contributing to economic collapse of Canada, reducing us to a highly indebted, hewers of wood, drawers of water economy, a natural resource providing colony.

On [March 28, 2014](#), Bill Ross Enterprises Ltd, made a corporate HST payment of \$8900.00 to Revenue Canada. On May 30, 2014, this corporate HST payment was stolen from the HST account of Bill Ross Enterprises Ltd. (an independent individual) and used to pay the equivalent decreed debt of Bill Ross, the individual. Bill Ross Enterprises Ltd. immediately complained regarding this theft by phone call to Revenue Canada and was basically told: no, we can do whatever we want (translation to realspeak: pay up or die).

This has left Bill Ross Enterprises Ltd. in the position that any tax payments required to maintain scrupulous compliance with tax laws cannot be made because Revenue Canada is of the opinion that corporate tax payments can be stolen and applied to an unrelated individual. By this illegal trap, Bill Ross Enterprises Ltd cannot make tax payments to remain in tax compliance, despite a history, will and stated intent to be a law abiding corporate citizen. If the consequences if this theft is allowed to stand, the result and intent is clear: Destroy Bill Ross Enterprises Ltd as part of a campaign to destroy Bill Ross, the individual, for standing up against tyranny and for the law, as written (but not as interpreted by rule of corrupt man, enslaving others).

Thus far, the funds stolen from Bill Ross Enterprises Ltd. exceeds outstanding Federal and HST taxes and, Bill Ross Enterprises is not yet and desires to not be in a tax arrears position, but to remain legally in full compliance with applicable tax law. Bill Ross Enterprises Ltd. unambiguously demands that this stolen HST payment herewith and henceforth be returned to the corporate HST account and that assurances be received from Revenue Canada, in writing that future tax payments will not be similarly diverted as a precondition to any future corporate tax payments. Once the theft is reversed and assurances that this theft will not be repeated, Bill Ross Enterprises Ltd. undertakes to make all tax payments in a timely manner. Otherwise, Bill Ross Enterprises considers this theft a criminal aggression but has not yet decided what response is merited.

Further, by incessant Revenue Canada notices to service providers, such as my bank, Bill Ross Enterprises Ltd., like Bill Ross has no credit rating (despite meeting all agreed obligations) to bring to market products (and resulting manufacturing jobs) that have been in development for many years. Bill

Ross Enterprises Ltd, as Bill Ross may be forced to flee the Canadian socialist paradise, by and for the predators just to survive and to have some small measure of peace.

## Further Evidence, Legal Records, Past Correspondence

Full records, including legal of the initial predatory / criminal assault against myself and family by our corrupt divorce courts (which were confirmed by Parliamentary / Senate investigation) which have thus far resulted in obstruction of justice and no remedial action from our lawmakers, nor judiciary are available online:

...which is WHY civil disobedience and self-defense is AGAIN called for to restore the rule of law, rights and freedoms that Canadians have historically fought and sacrificed so much blood and treasure for, against tyranny and frankly, enemies domestic infesting our governments and law, traitors to Canada and Canadian values / laws of peace, fairness and justice.

## What I demand

All dollar values stated are in terms of when I initially stated these demands ([July 25, 2007](#)), adjusted for inflation. Note that the yearly cost to Canadians and families of not dealing with criminal assaults against the family institution and teaching children properly, to become personally responsible adults alone far exceeds the costs of my demands.

- Immediately undo theft and diversion of Bill Ross Enterprises Funds to bogus, decreed tax debt of Bill Ross, the individual. Respect the fact that Bill Ross Enterprises Ltd. is a separate, independent legal entity and does not want to be involved in this unrelated dispute.
- Immediately undo all liens against my property and enforcement of income tax opinions against myself that do not and cannot exist in law which precludes compulsion (servitude).
- \$Thirty Five Million Dollars for myself.
- \$Five Million Dollars immediately invested in trust for each daughter, maturing (payable to them) when they reach thirty years of age in compensation for the illegal childhood abuse / conflict, loss of security and peaceful childhoods imposed on them.
- \$Five Hundred Thousand Dollars in trust for my ex-wife, to be jointly managed by my daughters in compensation for how her corrupt lawyer and system tricked her into being a pawn, lying and whining for entitlements to falsely rationalize predatory assaults on me and my ability to parent my daughters to become personally responsible adults.
- Drop all considered / current legal charges, social services repayment demands, or any blame against my poor manipulated ex-wife. She has suffered, by her own hands far more than I would have chosen, even if vengeance were a consideration, which it has never been. She was a pawn, but a willing one, chasing false, illegal promises of irresponsibility and survival without effort. She was confronted with a system which encouraged presenting lies to the court and manipulating / abusing her daughters appeared to be more profitable than working and contributing to society. The same antisocial / illegal behavior was shared by her lawyer, psychiatrist (convicted criminal) and courts.
- Put ex-wife on lifetime modest pension with full medical / dental, addiction treatment.
- Lifetime stop harassing me to volunteer for income tax or reporting demands. Respect the fact that my not volunteering to support government is permanent, by freedom to not associate with criminals and to avoid being accessory to crimes.

- Change laws to prevent legal aid from being used for offensive purposes or any non-criminal matter. Note that, in order to qualify for legal aid during divorce proceedings, it was a qualification requirement that my ex-wife allege abuse by myself. Some judges have publicly stated that, when confronted with unproven allegations of abuse, they do not dare award parental rights to the alleged “abuser”.
- Change laws to exempt children’s University Scholarships from bankruptcy proceedings. These scholarships (which I paid for) were transferred to ex-wife in divorce proceedings and nearly lost in her bankruptcy until she signed them over to me.
- Change (make compliant with true law) divorce laws to define marriage as a partnership between equal persons in pursuit of shared goals, repeal “no-fault” divorce laws, pre-nuptial agreements are legally inviolate (spouses define their own terms of association, not politics), subject to mutually agreed amendments over time, joint custody, equal time, decision power with each parent, no child or spousal support payable to other parent unless proposed paying parent is unwilling / provably unable to care for children properly. This will allow children to experience and learn the consequences / differences between each parent’s choices / values so they can learn and choose personal responsibility in life, contributing to overall growth of civilization and collective survival.
- Police investigations and criminal charges if merited of my ex-wife’s lawyer and psychiatrist for perjury, uttering false documents, obstruction of justice, abuse of process, falsifying court orders, defrauding Legal Aid and OHIP by charging them for representing lies to the court, being accessories to child abuse and any other crimes that may come to light. Punitive damages totaling all assets and insurance of above individuals to the state in partial repayment of this settlement. Stripping these two individuals of all professional credentials to remove hazards to society. Garnishment of their future earnings to pay for cost of state support of my ex-wife due to their abuse of authority and manipulating her to falsely allege abuse, tricking her into falsely claiming victimhood, destroying her personal responsibility and manipulating her to behave in a manner which precluded her from attempting to address her problems or taking her rightful position as parent to her daughters who are now irredeemably estranged.
- All reparations above are tax free or after tax for the recipients.
- If these terms are met, I am willing to sign a non-disclosure agreement which becomes null and void if the legislative initiatives demanded are not in place within five years of settlement or if the police investigation and court proceedings are less than diligent. It is morally acceptable to me if I achieve the above changes, placing us all on the correct moral / legal path in the small but crucial matter of treating children properly and allowing children to have stable/secure childhoods.

## **In Conclusion**

I have NOT and will NOT be complicit in the crimes outlined above. I would rather be on the street, on social services, in jail or dead than allow the lives of my ancestors who fought and died for freedom and rule of law to be wasted, thrown away by me and other sane people of ability being too cowardly to oppose. I have thus far represented and respected true law and the best interests of all concerned, at great cost, including my fellow Canadians, my daughters, my ex-wife (all would have been well if she had accepted personal responsibility, as demanded by written law, she created her own woes) and honest, hardworking, socially conscious members of government and the judiciary. We all need to oppose illegal orders / process and focus on peace and common interest, Canada's historical role domestically and

internationally. United we stand, divided we are falling.

And, the reason that the rule of law and equal treatment by law of all human beings cannot be compromised is that each compromise is a crime which pays, increasing the power of criminals to the point they can force greater compromises eventually, resulting in civilization being at the point it is now: collapsing to social / economic chaos, tyranny nearly complete.
